1. Introduction

Reaseheath Mini Zoo is committed to integrating sustainability into all aspects of its operations, aligning with Reaseheath College's broader sustainability objectives. Our goal is to foster environmental stewardship, reduce our ecological footprint, and inspire our community to engage in sustainable practices.

2. Sustainability Objectives

In line with our commitment to sustainability, we aim to:

- Reduce unnecessary consumption and waste creation.
- Reuse resources wherever possible.
- Recycle materials to minimize landfill contributions.

- Use energy from green sources and evaluate opportunities for solar panel installation and fleet decarbonisation.
- Collaborate with local suppliers to source feed, shop stock, and other items locally, reducing transportation emissions.

Biodiversity and Conservation:

- Improve habitat diversity on-site through tree planting, wildflower areas, and pond management.
- Participate in conservation breeding programmes such as EEPs and ESBs to protect threatened species.



Education and Visitor Engagement:

- Encourage visitors to adopt sustainable practices at home via education trails, signage, and interpretation.
- Run educational programmes highlighting sustainability and conservation principles.
